## Independent Committee in relation to the fire at Wang Fuk Court in Tai Po

### Invitation to the Public and Relevant Organisations to Provide Information

The Chief Executive has established an Independent Committee in relation to the fire at Wang Fuk Court in Tai Po to review the causes and related issues of the fire, and to make recommendations to prevent similar incidents from occurring again. The Committee formally commenced its work on December 19, 2025.
