

**Independent Committee in relation to the
Fire at Wang Fuk Court in Tai Po**

**2ND WITNESS STATEMENT OF
LAU YUET-CHUN**

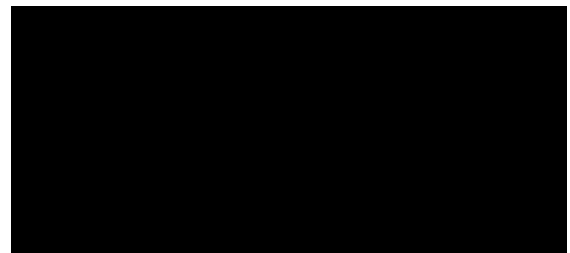
I, LAU Yuet-chun, Senior Inspector of Police, Hong Kong Police Force, of the New Territories North Regional Headquarters, No.6 On Po Lane, Tai Po, New Territories, Hong Kong do say as follows:-

1. I am the same LAU Yuet-chun who made my Witness Statement dated 16 January 2026 (“**1st Witness Statement**”) pursuant to the request of the Committee. Save where otherwise appears, I shall adopt the abbreviations and nomenclature used in my 1st Witness Statement.
2. I make this Witness Statement to update the graphical illustration for presenting the locations of injuries and fatalities in the Wang Fuk Court fire (“**Fire**”) which was attached as Annex 1 to my 1st Witness Statement. Save where otherwise appears, the facts deposed hereto are within my personal knowledge or are derived from office files and records and sources to which I have access and which are true to the best of my knowledge, information and belief.
3. As mentioned in my 1st Witness Statement, I prepared the Annex 1 attached thereto as a graphical illustration to show the found locations and personal particulars of the injuries and fatalities in the Fire after obtaining the relevant information of the injured persons and deceased from Chief Inspector of Police of Regional Technology and Financial Crime Unit of Crime New Territories North Region, Ms LEUNG Yee-mei, April and Chief Inspector of Police of Regional Crime Prevention Officer New Territories North Region, Mr WONG Cheung-hing respectively. Subsequently, I received updated information about the injured persons and deceased from each of them, which as I understand would be reflected in the Updated Composite List of Injures (as of 9 March 2026) to be attached to the 3rd Witness Statement of Leung Yee-mei

April and the Composite List of Fatalities (as of 3 March 2026) to be attached to the 3rd Witness Statement of Wong Cheung-hing. As I received such updated information, I have prepared and attach hereto as **Annex 1** an updated graphical illustration showing the locations of injuries and fatalities identified in the Fire (as of 9 March 2026) (“**Updated Graphical Illustration of Injured Persons and Deceased**”).

4. In the Updated Graphical Illustration of Injured Persons and Deceased, all updates are highlighted in yellow. Updates include the found locations of injured persons and deceased, and the figure of the summary and breakdown of the number of injured persons and deceased found on each of the floors and in each of the buildings in Wang Fuk Court.
5. I confirm that the contents of this Witness Statement are true to the best of my knowledge, information and belief.
